10. The institution, if unaided, shall maintain endowment and reserve fund as per NCTE norms.
11. The institution shall continue to fulfill the norms laid down under the regulations of the NCTE and submit to the Regional Committee the Annual Report and the Performance Appraisal Report at the end of each academic year. The performance appraisal report should *inter alia* give the extent of compliance of the conditions indicated above.

By notification dated 30.04.2003 dated 30.04.2003 in Order No. (1) read above, Bangalore Nagar-Kote Sri Lakshminarasimhaswamy Dharmasasthan Institution has been placed in the list of notified institutions (1's 21) of the Karnataka Hindu Religious Institutions and Charitable Endowments Act, 1997 (Karnataka Act No. 33 of 2001)

Govt. dated 14.07.2014 vide Order No. (2) read above Bangalore Kote Sri Lakshminarasimhaswamy Dharmasasthan is not a religious institution or a Dewan. This institution is a religious institution. Section 35(1) of the Karnataka Hindu Religious Institutions and Charitable Endowments Act provides that the remaining clauses shall not apply to any religious institution or charitable endowment established, conducted or managed by a religious class, except Chapter VIII of the Act, as the proviso "Karnataka Hindu Religious Institutions and Charitable Endowments Act 1997" Case 3 It is ordered that Sri Lakshminarasimha Swamy Dharmasasthan be excluded from the list of notified institutions and amended vide Government Notification No. KE 77 MET 2003 dated 30.04.2003 and the entries of Sri Lakshminarasimha Charities and related entries in serial number 52 of the said notification shall be omitted.

Order No. (3) read above vide Government order dated 28.07.2014, Bangalore City, Kote Shree Lakshminarasimhaswamy Institute has been ordered to frame, approve and order new revised rules on the model of the pre-existing regulations of the Karnataka Hindu Religious Institutions and Charitable Endowments Act, 1997 and as read in (4) above. Order dated 20.09.2022 amended certain sub-rules in the said rules.



As read above (51) Government order dated 10.08.2018, Bangalore City, Kote Sri Lakshmi Narasimha Swamy Dharmasasthan (Rule 4 of the new revised regulations) has constituted a Management Committee for a term of two years and the term of the Committee will expire on 09.08.2022. Accordingly Sri Lakshmi Narasimha Dharmasasthan Management Committee Rule 4 Voting for the Term Committee. The Government has decided and ordered as follows to form a Management Committee of Chairman and Members.

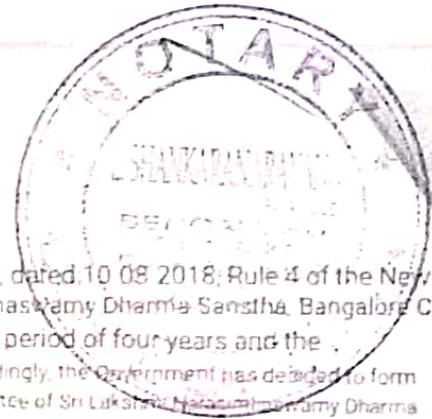

Government Order No. (2) read above dated 14/07/2014 Bangalore Hote Sri Lakshminarasimhaswamy Dharmasithana is not a religious institution or Devassanana, the institution of which is a religious institution. Section 35(1) of the Karnataka Hindu Religious Institutions and Charitable Endowments Act provides that "except Chapter VII of the Act, the remaining provisions shall not apply to any religious institution or charitable endowment founded, organized, conducted or managed by a religious class." It is ordered to exclude Sri Lakshminarasimha Swamy Dharma Institute from the list of notified numbers published under the Karnataka Hindu Religious Institutions and Charitable Charities Act 1997 Act 23 and amended vide Government Notification No. KE 77 MET 2003 dated 30/04/2003, in order No. 52 of the said notification Sri Lakshminarasimha Charities and related Entries are discarded.

Order No. (3) read above vide order of Government dated 28/07/2014 for Kote Sri Lakshminarasimhaswamy Institute, Bangalore City, making new revised rules on the model of the rules existing before the coming into force of the Karnataka Hindu Religious Institutions and Charitable Endowments Act, 1997, is hereby approved and annexed to Government Order No. (4) read above. 
